# **Certificates of Commendation**

Certificates of Commendation are awarded to members of the public, rail staff, fire officers and police officers, who have shown outstanding courage or particular skill.

It is important to thank members of the community who actively help the fire and police service to carry out their duty, as well as those who show great courage and initiative in helping others during a major emergency.

Certificates of Commendation serve to recognise such people and to express thanks and appreciation for the consent, goodwill, and active co-operation of citizens.

### The Great Heck Rail Crash

At 6.12am on Wednesday 28<sup>th</sup> February 2001, a Land Rover pulling a trailer on the westbound M62 motorway in North Yorkshire, left the carriageway and ended up fouling the main southbound line. Almost immediately afterwards, the 04.45 GNER passenger train from Newcastle to London King's Cross struck the Land Rover, partially derailing the driving cab. Some fifteen seconds later, the passenger train struck an oncoming freight train carrying coal. The two trains were derailed, killing the coal train driver and the passenger train driver, together with eight other people on the passenger train, including rail crew members. Eighty six people were injured, some severely.

### Chief Constable's Commendation Recipients:

#### Mr Eric Andrew Booth

Mr Booth is commended for his actions immediately following the collision. After aiding a female passenger in escaping from a carriage, he ran up the railway in search of a functioning signal box and alerted the signalmen he found there to the magnitude of the crash. He then spoke to a signalman at Doncaster and informed him of the location of the crash before returning to the site of the crash.

#### Mr Martin Gaunt

Mr Gaunt is commended for his actions immediately following the collision. Despite sustaining a broken arm, Mr Gaunt ran to Northern Straw in order to call the emergency services. When he realised that had been done, he returned to the scene and helped several passengers pass safely through downed electric lines and down an embankment. Mr Gaunt showed several people to the safety of Northern Straw. He then alerted a nearby paramedic to the location of a trapped passenger before being taken to hospital himself.

#### Mr Richard Genner

Mr Genner is commended for the way in which he assisted his fellow passengers immediately following the collision. Despite injuries to himself, Mr Genner helped clear wreckage from several passengers trapped in his carriage and remained in the carriage to comfort and reassure them.

#### Mr Laurence Gunson

Mr Gunson is commended for the assistance he provided a fellow passenger immediately after the collision. Having suffered an undiagnosed broken neck and badly injured shoulder himself, Mr Gunson spent an hour and a half comforting a fellow injured passenger while the two of them, trapped in a carriage, awaited emergency services.

#### Mr Peter King

Mr King is commended for the way in which he assisted his fellow passengers immediately following the collision. Despite sustaining injuries himself, Mr King removed wreckage from seriously injured passengers, comforted them, administered first aid to them and kept them conscious until emergency teams arrived. In spite of the danger to himself, Mr King refused to leave his travelling companions until emergency services had arrived.

#### Mr Nev Lyon

Mr Lyon is commended for his actions immediately following the collision. His carriage having been overturned, Mr Lyon helped extricate a man trapped between what had been the ceiling and the luggage racks by clearing the debris covering him. Hoping to prevent further injury to the passenger, Mr Lyon encouraged the man to remain still until emergency teams arrived. Upon exiting the carriage, he informed a passing fireman of the location of another man he believed to be trapped under the wreckage of another carriage.

#### Mr Kenneth Mellor

Mr Mellor is commended for his actions immediately following the collision. After escaping his carriage, Mr Mellor ran to a nearby farm yard to find ladders with which to free other trapped passengers in a nearby carriage. When the first ambulance arrived, Mr Mellor directed it to the best access route to the site and remained on the road to direct subsequent ambulances. Upon returning to the farmhouse, Mr Mellor comforted a passenger there.

#### Mr Brian Patterson

Mr Patterson is commended for his actions immediately following the collision. After escaping his own carriage, Mr Patterson comforted a severely injured man who had been thrown from the train. He then helped several other passengers in a different carriage to escape by smashing a window. He returned several times to comfort the severely injured man, provided him with a jacket in order to keep warm in the freezing weather, and later led fire-fighters to him. Mr Patterson then comforted a passenger anxious about the welfare of her travelling companion.

#### Mr Richard Simpson

Mr Simpson is commended for the way in which he assisted his fellow passengers immediately following the collision. Following the crash, Mr Simpson informed his fellow passengers that they would be safer staying in the carriage. He then exited the carriage himself and went to the aid of passengers trapped in other carriages where he administered first aid to several passengers. Seeing that emergency services had arrived on the scene, he apprised a fire officer of the location and condition of the injured passengers he had treated. Mr Simpson joined the fire crew and helped them administer first aid to several passengers remaining in train carriages and assisted in removing passengers from the wreckage.

#### Ms Emma Kirvan-Taylor, (to be received by Mr and Mrs Kirvan)

Ms Kirvan-Taylor is commended for the way in which she assisted passengers immediately after the crash. Despite being badly injured herself, she managed to free herself from a pile of debris. Once free, she comforted passengers in the buffet car, before exiting the train through a broken window. Ms Kirvan-Taylor then reassured injured passengers outside the train and led a group of them to a place of safety. She then went back to the train to assist more people.

#### Mr Raymond Leslie Brindley, (to be received by Mr Ashley Brindley)

Mr Brindley is commended for his actions immediately following the collision. Having established that there was no danger of fire within the coaches, he advised passengers to keep calm and stay inside the coach. Mr Brindley then alighted from the coach he was in and ran to the contact the signalman on the signal phone. Having done this, he subsequently directed the arriving emergency services to the scene, and then helped with the removal of injured passengers from the train.

#### Mr Thomas Waller

Mr Waller is commended for the way in which he assisted his fellow passengers immediately after the collision. After escaping from his carriage, Mr Waller helped another passenger exit the train and then dialled 999. He also assisted another trapped passenger by giving her his coat to ward off the cold.

#### Mr David Ward

Mr Ward is commended for the way in which he assisted his fellow passengers immediately following the collision. After helping a passenger exit the carriage, Mr Ward dialled 999 to inform the fire brigade of the accident. Mr Ward then comforted a carriage full of trapped passengers, telling them help was on the way. He then assisted 8-10 passengers in exiting another carriage and directed them toward Northern Straw.

#### Mr Michael Wilson

Mr Wilson is commended for the way in which he aided his fellow passengers immediately following the collision. After phoning emergency services, Mr Wilson comforted a severely injured man and gave him the lining out of his own jacket in order to help keep the man warm. Mr Wilson then flagged down an emergency vehicle and informed the officer of the location and condition of the trapped man. He then made numerous trips guiding several passengers to the Northern Straw offices.

#### Mr Malcolm Bramley

Mr Bramley is commended for his assistance at the scene of the collision. He arrived at the site after the crash and helped to rescue an injured train driver using a rope he had provided. He helped place the driver on the stretcher and carried the stretcher to a waiting ambulance. Mr Bramley then assisted in directing traffic at the site.

#### Mr Thomas David Bramley

Mr Bramley is commended for his assistance at the scene on his property. After dialling 999 to inform the authorities of the crash, he and other family members aided a fireman in the rescue of a trapped train driver, Mr. Andrew Hill, and provided general assistance at the site.

#### Mrs Fiona Claire Bramley

Mrs Bramley is commended for her assistance at the scene on her property. She helped care for and comfort several of the passengers who had come to take refuge in her mother's house.

#### Mr Gregory Cooper

Mr Cooper is commended for the way in which he assisted several of his fellow passengers immediately following the collision. After phoning 999, he climbed into several carriages in order to assist injured passengers and removed wreckage in order to help passengers exit the train. He also comforted one injured, trapped passenger and helped another suffering from chest pains. Next, he directed a paramedic to these injured passengers and then, aided by a fireman, assisted in the removal of another injured passenger from the wreckage of a nearby carriage. Subsequently, he escorted four passengers to safety through downed power lines and across an embankment. He then returned to Northern Straw and cleared equipment in the area in order to open a workshop to cater to the injured. He continued to work to comfort passengers in this makeshift clinic.

#### Mr John Dunington

Mr Dunington is commended for his prompt and effective response to the collision. Having arrived to work at Northern Straw after the crash, Mr Dunington worked to assist and comfort the injured passengers and to open rooms in Northern Straw to allow passengers to escape from the cold.

#### Mr Gerald Hall

Mr Hall is commended for his prompt and effective response to the collision. After hearing the crash, Mr Hall went to the site and directed several disoriented passengers to the Northern Straw makeshift facility. He helped to transport an injured woman to safety and informed newly arrived paramedics of the location of the site. Mr Hall then returned to Northern Straw and worked to reassure and comfort the injured passengers he found there. He then opened another Northern Straw shed to provide shelter for injured passengers. Having done this, Mr Hall assisted in moving scrap and debris, allowing Ambulance access to the last shed where many of the most seriously injured lay.

#### Mrs Susan Lynn Hall

Mrs Hall is commended for her prompt and effective response to the train crash. After hearing the crash, Mrs Hall went to the site and provided blankets and warm clothing for the survivors. She further comforted the injured and provided them with hot drinks until they were taken to hospital.

#### Miss Stephanie Hall

Miss Hall is commended for her prompt and effective response to the train crash. Following the collision, Miss Hall, without prompting, went to see what assistance she could provide. She then returned to her house to collect and provide facilities to administer hot drinks to the injured.

#### Mrs Sharon Matthews

Mrs Matthews is commended for her prompt and effective response to the collision. As a Registered Nurse, Mrs Matthews, a local resident, was anxious to help when she heard of the incident. Once at Northern Straw, she assisted emergency personnel and comforted the injured.

### Mrs Lynn Margaret Patrick

Mrs Patrick is commended for her prompt and effective response to the collision. Upon hearing of the crash, Mrs Patrick, a Registered Nurse, went to the scene in order to determine if her medical skills could be of some use. Discovering that her skills were indeed needed, Mrs Patrick returned to her village in order to inform her friend and fellow Registered Nurse that they were needed at the crash site. Mrs Patrick went on to assist and comfort the injured passengers being housed at Northern Straw.

#### Mr John Peter Smith

Mr Smith is commended for his prompt and effective response to the collision. Upon being notified of the crash, Mr Smith travelled to the scene and assisted the paramedic in recovering Mr. Andrew Hill, surviving driver of the freight train.

### Mrs Karen Dawn Smith, (to be received by Mr Smith)

Mrs Smith is commended for her prompt and effective response to the collision. Upon being notified of the crash, Mrs Smith travelled to the scene and helped care for and comfort several of the passengers who had come to take refuge in her mother's house.

#### Mr Arnold Whittles

Mr Whittles is commended for his prompt and effective response to the train crash. After informing emergency services of the location of the crash, Mr Whittles, with help, obtained ladders which he used to evacuate trapped passengers from the train. He also cleared a safe route to his home which he had opened up to the passengers and led an elderly passenger there. Subsequently, he returned to the site of the collision and convinced an injured passenger to exit the carriage and helped her to the Northern Straw offices. He returned to the site, helped several other passengers out of the carriage and led them to the Northern Straw Depot. He also assisted a paramedic in carrying a stretcher and comforting its injured occupant.

#### Mrs Gillian Whittles

Mrs Whittles is commended for her prompt and effective response to the train crash. After dialling 999 to inform emergency services, Mrs Whittles opened her house in aid and comfort to fourteen of the passengers.

# A Chief Constable's Certificate of Commendation is awarded posthumously to Mr Carlo Evans

At 6.12am on Wednesday 28<sup>th</sup> February 2001, a Land Rover pulling a trailer on the westbound M62 motorway in North Yorkshire, left the carriageway and ended up fouling the main southbound line. Almost immediately afterwards, the 04.45 GNER passenger train from Newcastle to London King's Cross struck the Land Rover, partially derailing the driving cab. Some fifteen seconds later, the passenger train struck an oncoming freight train carrying coal. The two trains were derailed, killing the coal train driver and the passenger train driver, together with eight other people on the passenger train, including rail crew members. Eightysix people were injured, some severely.

Mr Evans is commended for his actions immediately following the collision. After phoning 999, Mr Evans called the York signal box in order to alert them of the crash and ensure that no other train came down the line. He then flagged down a nearby driver, asked him the exact location and rang emergency services in order to update them. Mr Evans then returned to the site and helped several passengers escape the wreckage and helped secure the site by making dangerous debris safe. He then aided firemen and paramedics with their equipment. Subsequently, Mr Evans went to the Northern Straw depot in order to comfort and assist further the injured passengers brought there.
